

Conditions of participation «Do the Du-Da-Do»

By entering the prize draw, you fully accept and agree to the following terms and conditions.

All natural persons aged 16 or over who are permanently resident in Switzerland or the Principality of Liechtenstein are eligible to take part. The participant in the competition is the person who owns the email address that was provided when registering for the competition. Only one entry per category is permitted per person/group.

A participant's irregular or repeated participation in the competition shall result in their match being disqualified. Likewise, any automated participation or submission and any technical manipulation will inevitably result in exclusion from the competition. Participation is free of charge and free of any purchase obligation.

Only the competition prizes described in more detail in the competition will be awarded. Competition prizes will only be awarded to participants who have personally completed all the fields to be completed for participation in the competition in a complete, understandable and truthful manner.

PostBus reserves the right to suspend the competition completely or temporarily if it is suspected that the integrity of the competition is jeopardized.

PostBus undertakes to exercise due diligence at all times with regard to the handling of your personal data and to comply with Swiss data protection regulations. Your data may not be passed on to third parties, but we reserve the right to pass it on to any logistics partners for the purpose of sending competitive prices.

The closing date for entries is 18 August 2024.

The winner will be notified personally in good time using the additional details provided during the entry. The three winners in each category will be mentioned by name on the competition page with their post and will be invited to the prize-giving at the Museum der Kommunikation in Bern

Prizes will not be paid out in cash or exchanged. The competition prices are not transferrable. The winner accepts any changes to the prizes.

No further correspondence will be entered into regarding the competition; legal action is excluded.



Special regulations

In the submitted post, the sound sequence of the post horn is acoustically recognizable and/or the post horn comes visually.

Post horn

By submitting your contribution, you assign your rights to these contribution to PostBus to the extent permitted by law and grant authorisation to publish your works or to be included, where conservatively possible, in the collection of the Museum of Communication in Bern (applies only to the winning entries).

At the same time, by uploading the images you declare that they do not infringe any third-party rights, in particular copyright or personal rights. This means in particular that the participant has the permission of the person(s) depicted or the creator of the works to assign the image rights and to publish the image. If minors are depicted, the participant is required to obtain the permission of the parents or legal guardian.

Submissions of a racist, pornographic or otherwise offensive nature or those in breach of the contest rules are excluded.

Contributions must be sent in by e-mail (see template on competition page). For file sizes larger than 50MB, you can either use a file hosting service (e.g. WeTransfer) or upload your post to a social media platform (e.g. YouTube) and send us the relevant link. Posts can also be sent to the PostBus account as private messages via Facebook and Instagram.

Format specifications: maximum file size 50 MB

- PDF for texts
- JPG, PEG and PNG for images
- MP4 and AVI for videos
- MP3 and WAV for audio files

The jury will give a final verdict on whether the entries are admissible.

The jury determines the evaluation and decision-making process. When assessing the submitted contributions, it takes into account their creativity, quality, impact, topicality and innovative strength. The jury will introduce itself on the competition page.

The jury's decision is final.
